Keep out of reach of children. Product releases methanol during application and curing. May generate formaldehyde at temperatures greater than 150 C(300 F). Wipe, scrape or soak up in an inert material and put in a container for disposal. Wash walking surfaces with detergent and water to reduce slipping hazard. Wear proper protective equipment as specified in the protective equipment section.
